**Brief Description of Work**

Upgrades to existing Ameliasburgh Water Treatment Plant to be comprised of:

- Replacement of process PVC piping with Stainless Steel piping
- Replacement of pneumatically actuated valves with electrically actuated valves or solenoid-globe valves as shown on the drawings
- Relocation or installation of instrumentation and equipment
- Associated electrical and control and instrumentation work
- Temporary pumping to distribution system during critical shutdown
