

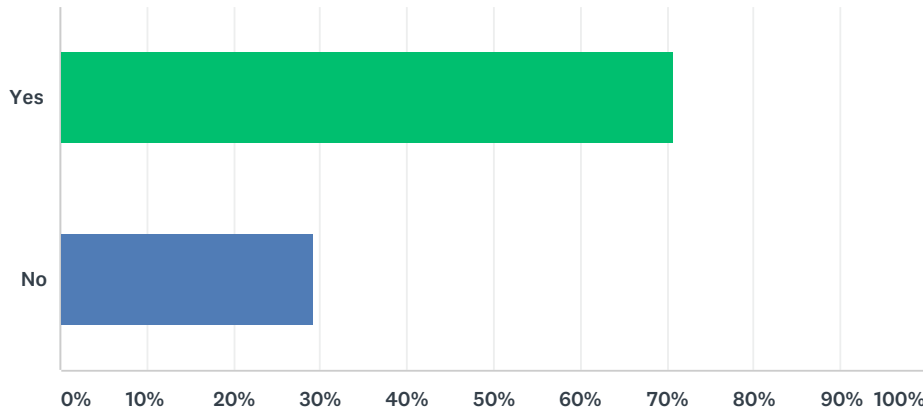

Q2 Have you personally used or tried cannabis in any form (edible, smoked, vaporized) at least once in your life?

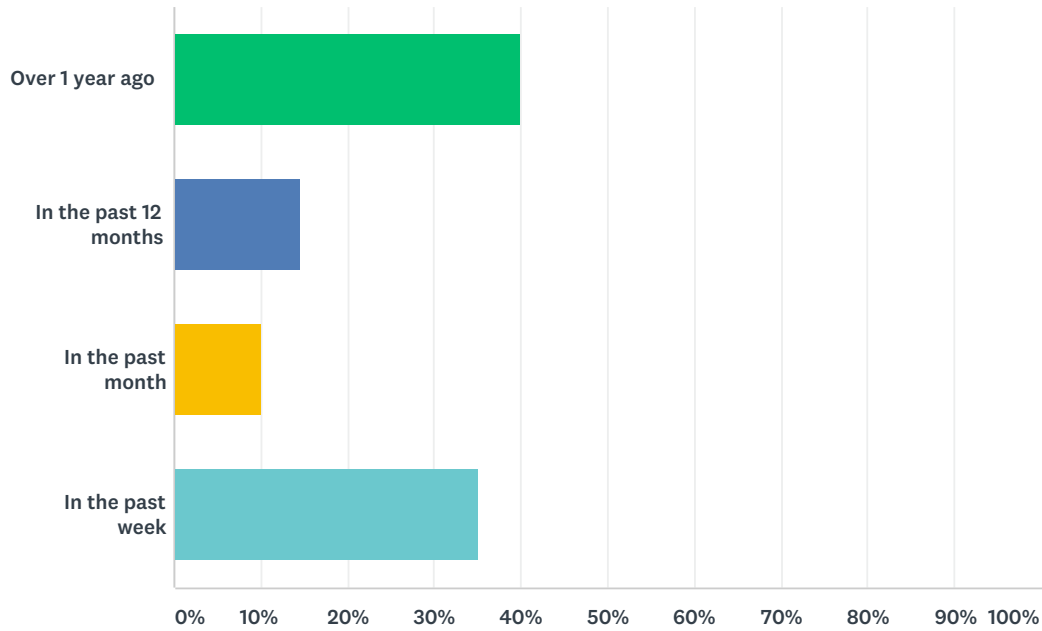

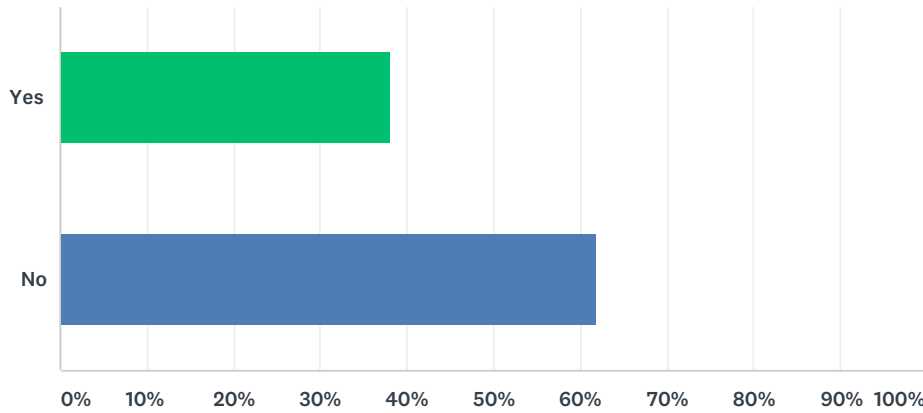
Q4 Do you support or oppose legal and tightly regulated cannabis retail stores in Prince Edward County?

Q5 Do you have concerns regarding legal and tightly regulated cannabis retail stores in Prince Edward County?

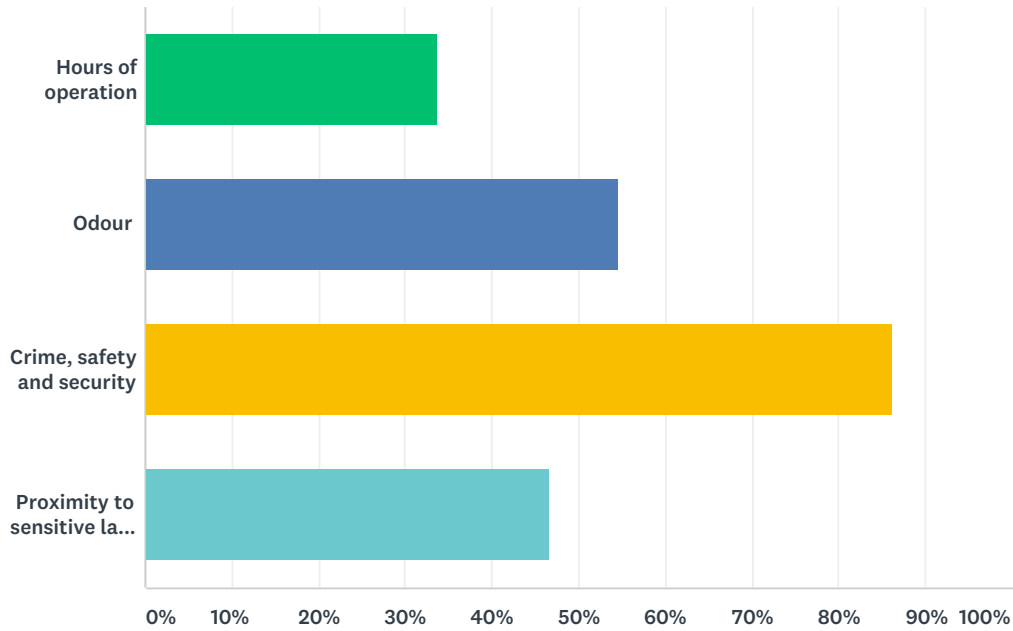

Q6 Please select any/all of your concerns about legal and tightly regulated cannabis retail stores in Prince Edward County?

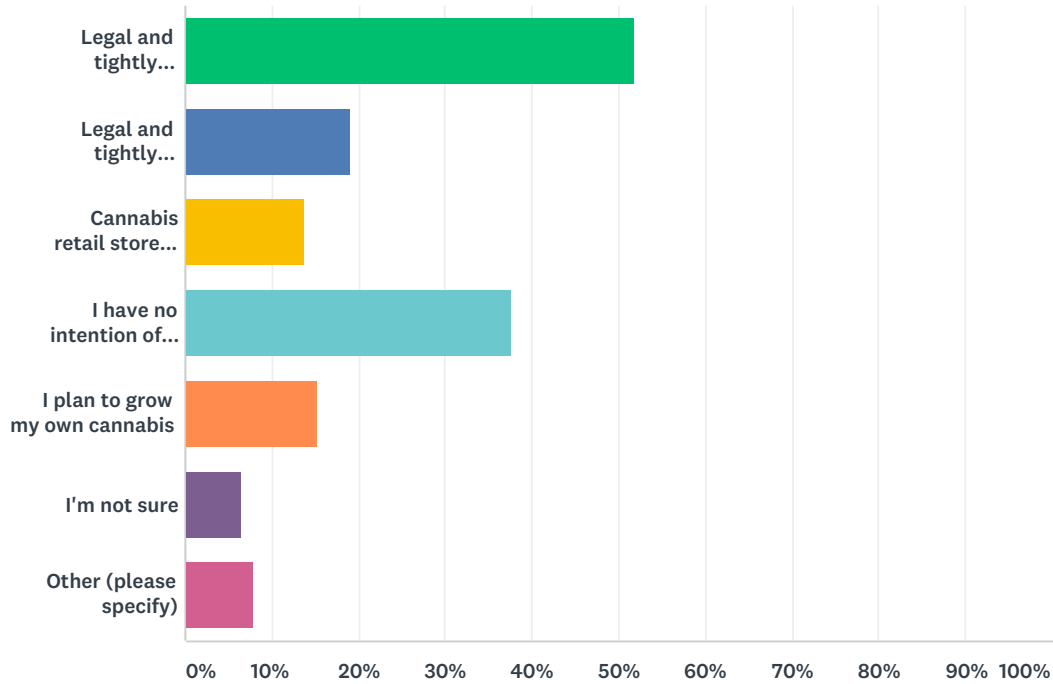

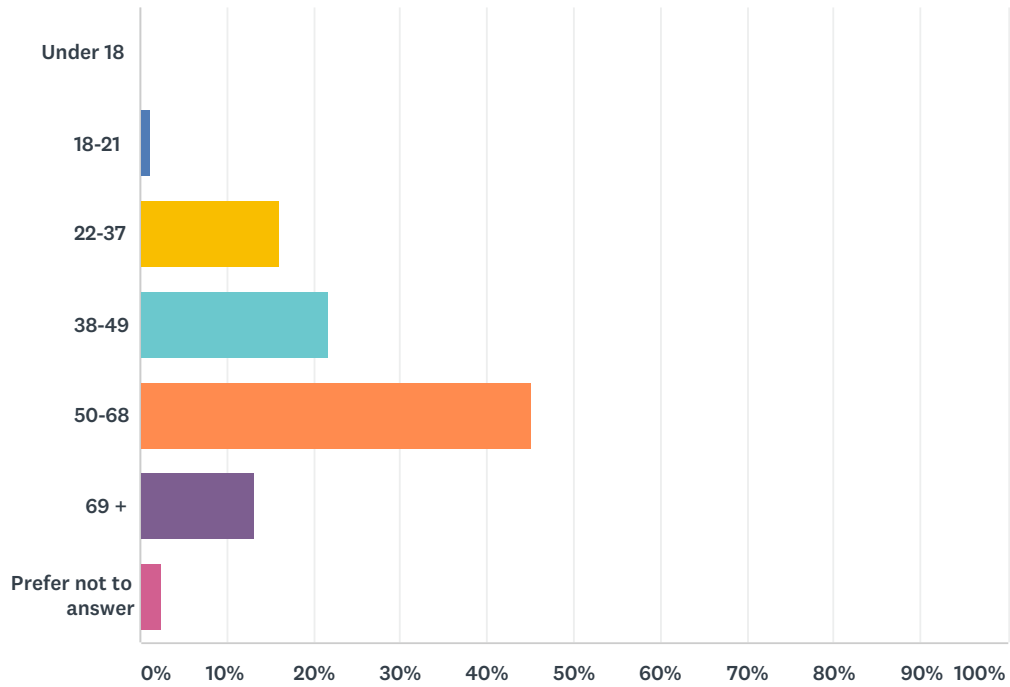
Q8 Do you feel legal and tightly regulated cannabis retail stores will create jobs and benefit the economy in Prince Edward County?

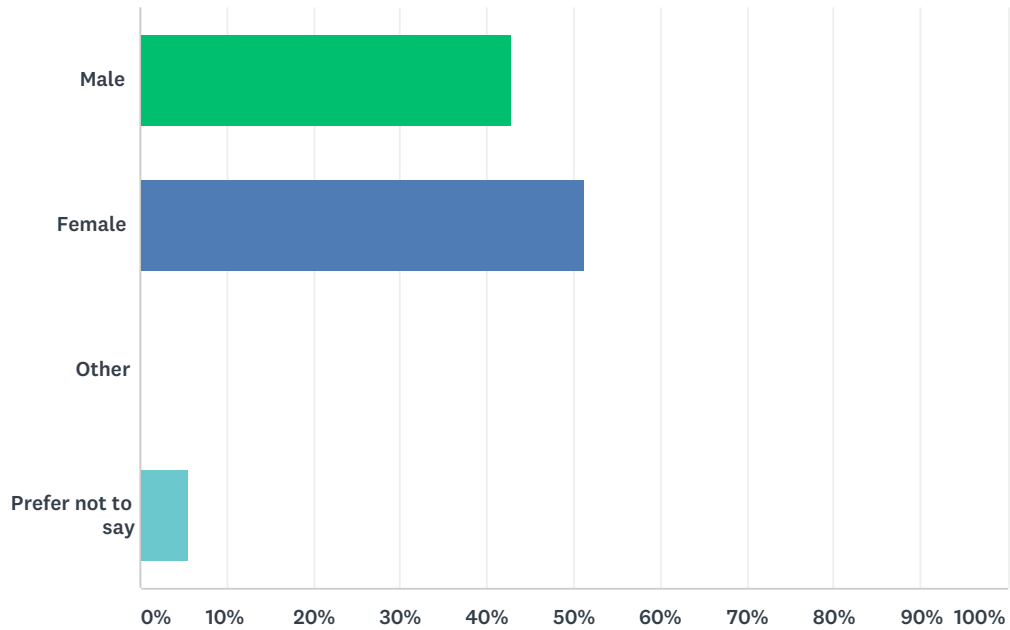

Q10 Which gender do you identify with?

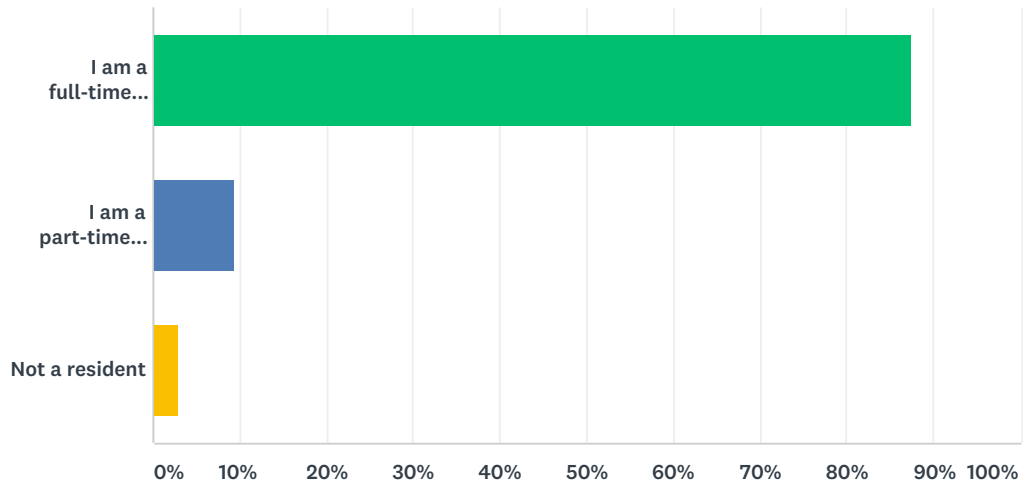

Q11 What is your residency status in Prince Edward County?

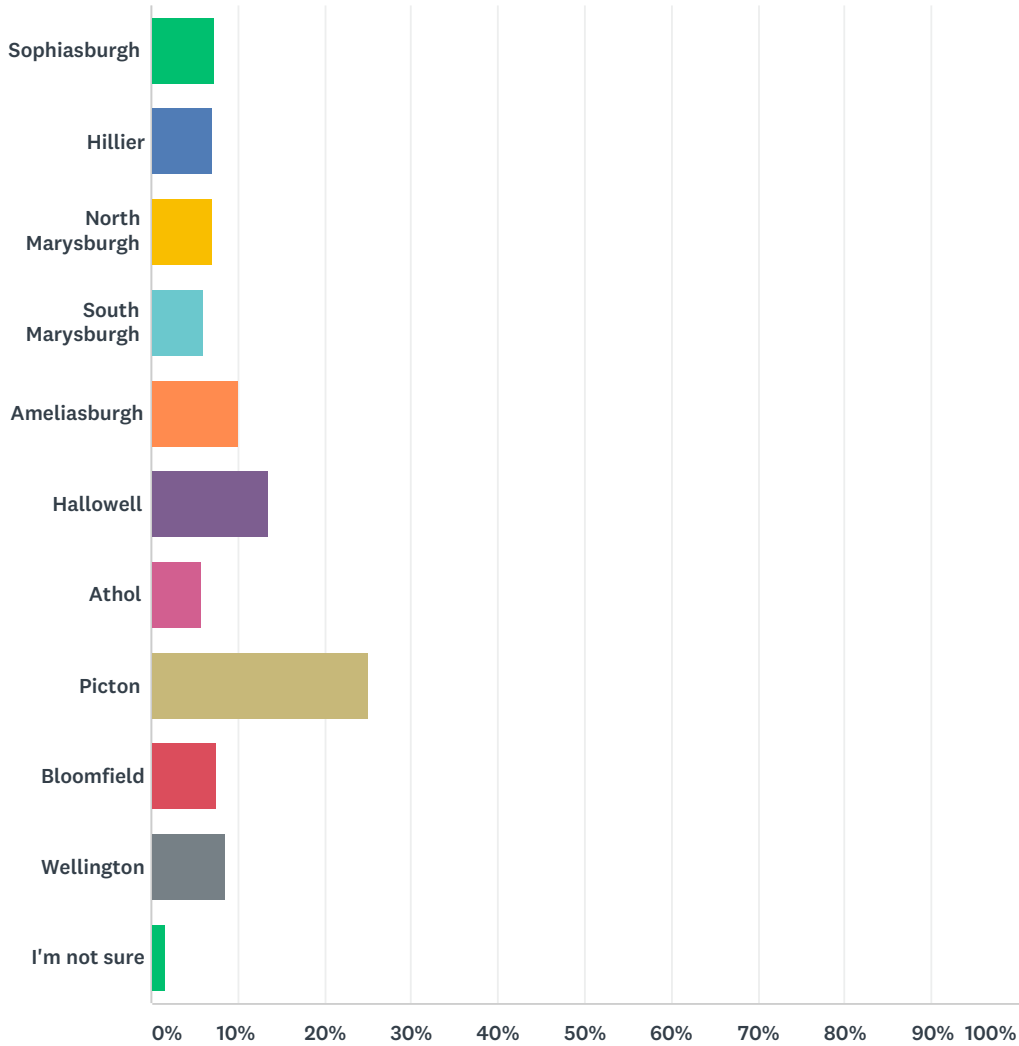
